#### **NEW COMMUNITY LANDSCAPER SELECTED**

Early this year, our volunteer Landscape Committee sought out contract bids from several well known landscaping companies in our area, including an updated bid from our existing landscape maintenance provider (BladeRunners). After careful review and analysis of their service offerings as well as in-person meetings with all of the bidding vendors, the Landscape Committee presented their recommendations to the Board or Directors during the January Board Meeting. **Ackman Bros. Landscaping, Inc.** was determined to be the leading choice and was selected as our new landscape maintenance provider effective April 1, 2015.

Please be advised: **Heavy pruning** will take place on some shrubs and trees that are not currently in good health. In some cases, things may look worse before they look better. We have confidence that Ackman Bros. will help us restore our plants and shrubs, but it will take some time. Please report any questions or concerns to Leland Management.

### **Important Reminders**

#### CHANGES TO LANDSCAPING OR HOME EXTERIOR

Mabel Bridge HOA uses design guidelines to maintain consistency with the overall design concept for the community. Among other things, these guidelines help to maintain an orderly appearance and enhance the visual and aesthetic appeal of the community. As such, **you must obtain written approval** from the Architecture Review Board (ARB) **before** changes are made to home exteriors such as painting, major landscaping, installing fences or pools, etc. To learn more about the ARB process or for assistance with submitting an application, you may contact our community manager, Vanessa Martinez from Leland Management at VMartinez@lelandmanagement.com and (407) 781-0778. ### **GENERAL SAFETY**

Remember, if you see **anything** suspicious in the community, **please call the police** via 911 or non-emergency number, 407-836-4357. Keep your home **well lit**, even when you are not home. Remind door -to-door solicitors that our community has clearly posted "no solicitation" signs, and do not open the door for strangers. **Please be safe!** 

### **COMMUNITY POOL RULES**

Every household received a copy of the pool rules along with their pool access key fob. Here are some select reminders:

- Pool hours of operation as required by the County Health Department are from "Dawn to Dusk" daily. Anyone caught using the pool area after the pool is closed will be subject to having their privileges revoked.
- Each household will be limited to a maximum of three (3) guests at the pool.
- All children under the age of 16 must be accompanied by and have continuous supervision by an adult (18 or older).

### ALL HOMEOWNERS ARE MEMBERS OF THE HOMEOWNERS ASSOCIATION (HOA)

When you purchased your property, which is governed by a homeowners association, you automatically became a member of the Mable Bridge HOA. The purchase of your home became a contract with the HOA. By entering this contract, all homeowners agree to follow the HOA rules, including paying HOA dues and other things like maintaining the appearance of our homes.

### ALL HOMEOWNERS ARE INVITED TO ATTEND HOA BOARD MEETINGS

All homeowners are welcomed to attend HOA Board Meetings. Meeting dates are posted on signs at the entrances to the community as well as on our community web site and Facebook page.

### MABEL BRIDGE HOA MEETINGS

During the BOD meeting, homeowners listen as the Board reviews / discusses:

- Management report from Leland Management including such things as HOA financials, vendor proposals, contracts, and violations.
- Any old or new business requiring BOD attention (Topics vary each meeting)
